

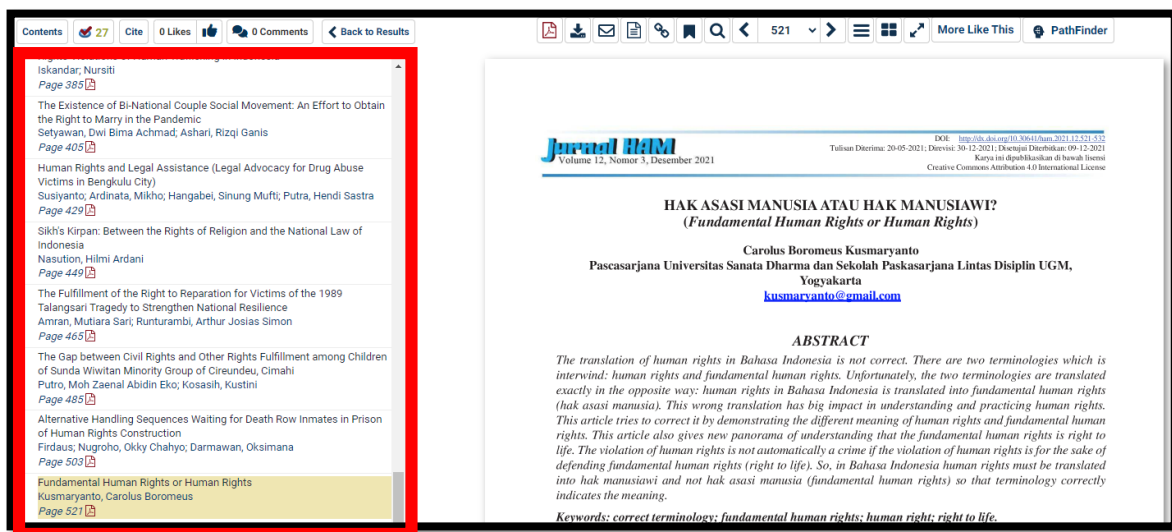
- 5) You can also modify your search, search within results, print the results page, toggle all matching text pages, turn on/off infinite scroll and mail your selected search results.



- 6) To the right of a result, you can find options to download, mail, save and like the document. You can also see the number of times the document has been accessed.



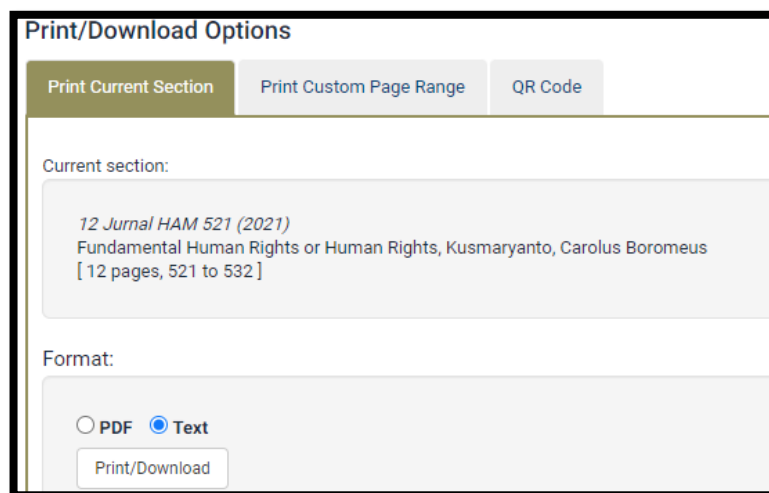
- 7) The table of contents, which has direct connections to each page number, is located on the left side of the screen while a user is browsing a document.



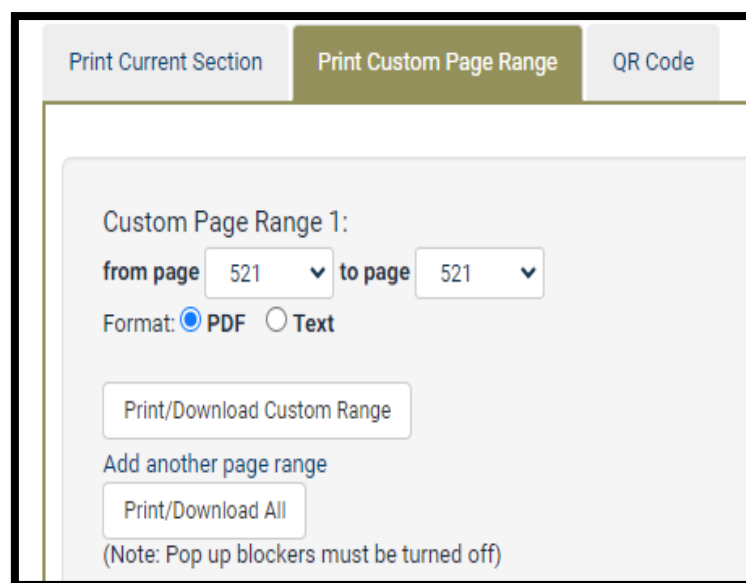
- 8) The options available in the image toolbar, which is situated right above a document: download or print a specific page range, send a PDF link via email, see the source text of the specific page, create a permalink to the particular page, bookmark the page, zoom & turn pages by navigating across them and modify the visibility of the page (fullscreen, zoom, etc.)



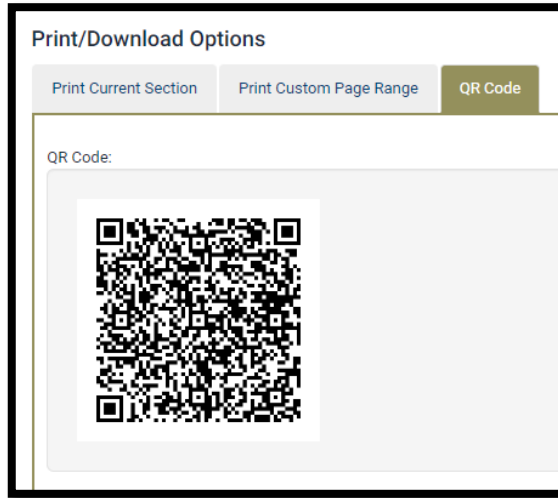
- 9) Print/ download options- PDF and text formats
- Print or download current section.



- Print or download custom page range



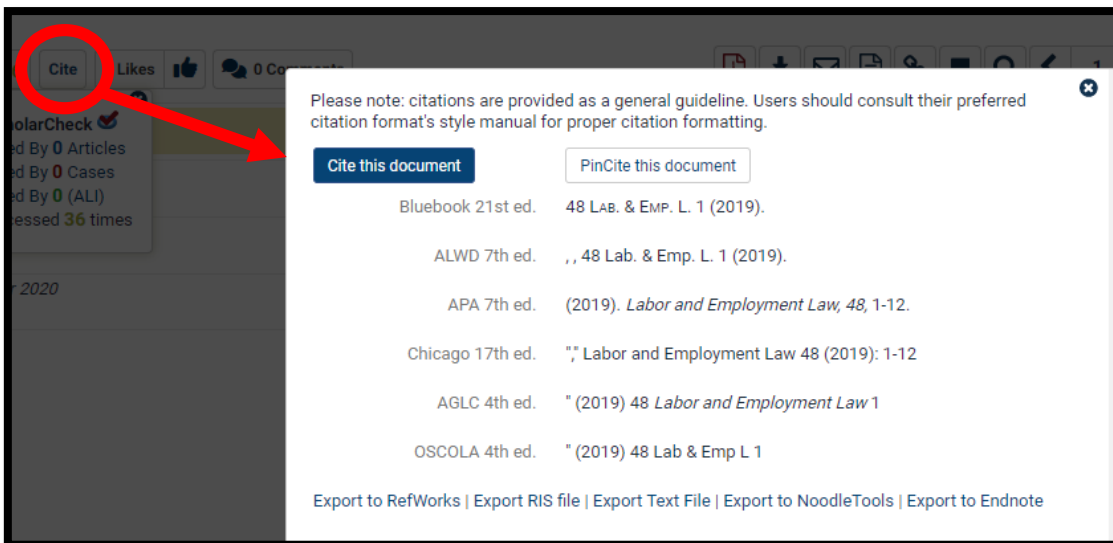
- Download in a different device using the QR code.



- 10) A coloured box with ScholarCheck metrics will appear above the table of contents while you are perusing a document.



- 11) Select the Cite button to copy or export (to RefWorks, Text file, NoodleTools, etc.) from multiple citation formats (APA, Chicago, Chicago, etc.)



12) Click on 'More Like This' to view similar articles based on the keywords found in the original article.



13) Examine the list of related articles, modify the boost factor for the intriguing phrases that the More Like This algorithm has identified, or add new terms to expand the search parameters.



(Note: Depending on the document type chosen, this option could change.)
